COST-SHARE PAYMENT

(MAXIMUM ANNUAL EXPENSE LIMIT INCREASED TO \$4250)

The Landowner Assistance Program limits reimbursement to 80% of documented expenses subject to County limits. This year applicants may claim up to \$3400 (80% of \$4250 expenses) in Bottineau County. HOWEVER, participation in both the Spring and Fall Program is necessary to claim the maximum annual reimbursement. If enrolled in only one of the programs the expense and reimbursement limits are reduced by half (\$2125 expense/\$1700 reimbursement).

If cost-share requests exceed available funds, payments will be made at a rate less than 80% and/or less than The \$3400 combined program limit; however, if program participation is low, caps on payments may be raised or Removed at the discretion of the WEED BOARD. Adjustments will be made in a fair and equitable manner.

HOW TO APPLY FOR COST-SHARE

1. Fill out both sides of this application. On the back, list the Township, Range, Section and Quarter locations. Name the owner and operator. List how many acres of LEAFY SPURGE are in NC-non cropland and GVT-government leased land (CRP,etc).
 2. Applicants must be owners or operators of the land.
 3. Send in current year receipts for herbicides purchased and a FSA map with leafy spurge infestations marked

**PLEASE READ TO UNDERSTAND DEFINITIONS OF TERMS,
RESTRICTIONS AND INTENT OF THE COST-SHARE PROGRAM.**

1: Spring season general weed control is a normal and necessary part of cropping operations. Any resulting spurge control becomes a side benefit that requires no extra expense or effort by the farmer.

The Weed Board has determined that the use of cost-share funds to supplement normal production practices is not the intent of the program and it is not an appropriate use of taxpayer dollars.

Therefore, spring spurge control cost assistance on tillable acres seeded in the current year for crop production has been suspended.

2: Herbicides not listed on the form will be considered for approval on an individual basis.

3: Commercial application reimbursement requires an active commercial license number. Non-commercial rates are as listed.

4: Maps submitted need to be CURRENT FSA maps that indicate land classifications. Use it as a base for your leafy spurge location map.

5: Based on a participant survey, the Weed Board has decided they will continue support for 2,4-D products but encourage use of more effective herbicides when possible.
